The required minimum of a freight forwarder in the port: 1. Coordination of vessel nominations and confirmation of L/C at the port. 2. Coordination with the port of windows for unloading wagons. 3. Coordination of work on weekends and holidays. 4. Coordination of the vessel loading plan. 5. Control over the correct storage of cargo and its placement, control of the storage location, and even control of cargo residues after loading. 6. Provision of wooden separation, fastening materials and proof of actual use of the material. 7. Closing the T1 customs declaration, clearance of goods at customs. Indicate in the proposal: 1. Cargo capacity of the warehouse, tons. 2. Vessel, wagon loading standards. 3. Technical characteristics of berths. 4. Conditions for fixing the vessel SSHINC-SSHEX. 5. Calculation of demurrage-dispatcher (or excluded). 6. Responsibility of the terminal for damage or loss of cargo. 7. Responsibility for unloading wagons, vessels on pre-agreed dates. 8. Cost of shunting work with railway wagons at the terminal (last mile) - euro per wagon. 9. Cost of overtime transshipment - euro per ton. 10. If necessary, unpacking CRC and HRC from polyethylene. 11. Cost of overtime transshipment - euro per ton
