We would like to inform you that "METINVEST-SHIPPING" LLC announces a tender for the purchase of services for transshipment and storage of pig iron through the port of Galati, Romania in September-October 2026 - 25,000 tons. Please submit your proposals according to the requirements below.

Other terms and conditions	Please send us an offer (price for railway shunting, handling, cost of cargo storage in an open warehouse, cargo securing, inspection, customs formalities, procedure, and payment terms) for the following transshipment in the port of Galati - free zone: - Scheme of logistics services / terms of delivery: DAP Galatz Larga station -> DAP free zone Galatz -> FOB Galatz port - Unloading cargo from wagons to an open storage, loading from an open storage to a ship, storage standards (TI) - The use of wagons must be included in the comprehensive rate. - Cargo type: - pig iron. - Approximately 25,000 tons in total - Origin of cargo: Ukraine - Time of arrival at the port of Galati: September - October 2026. Since the goods are delivered by Ukrainian wagons of the Ea type, the unloading of goods is mandatory within the facility with direct access to broad-gauge railway tracks. Considering the customs status of the cargo, it is also imperative that the warehouse/storage area is located within the free zone areas of the port. Required minimum freight forwarder at the port: 1. Coordination of vessel nominations and confirmation of the letter of credit in the port. 2. Coordination with the port of windows for unloading wagons. 3. Coordination of the loading plan. 4. Control over the correct storage of cargo and its placement. 5. Closing the T1 customs declaration. 6. Printing of necessary documents (MR, BL, Manifest and others). 7. Approval of necessary documents. 8. Sending documents by mail and DHL. 9. Reports on the presence of cargo in the port and on the route. These reports should contain complete information such as date of arrival and discharge at the port, balances at the port. In the offer, specify: - Rate of simultaneous cargo storage (tons). - Vessel loading speed (tons per day). - Mooring restrictions (draft, length). - Wagons unloading rate (Wagons per day).
